



Privacy Policy

TUIPOINT Registered Office: Tuipoint International Limited (Registered Company Number 1561115), Stanmore Bay, Whangaparaoa, 0932, New Zealand ("We") are committed to protecting and respecting your privacy.

This policy (together with our website terms of use and any other documents referred to therein) sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. By visiting www.tuipoint.com or by downloading our Tuipoint App you are accepting and consenting to the practices described in this policy.

We will only deal with your personal information in accordance with the Privacy Act 1993 and this privacy policy.

Information we may collect from you

We may collect and process the following data about you:

Information you give us. You may give us information about you by filling in forms on our site www.tuipoint.com ("our site") or via our Tuipoint App ("our App") or by corresponding with us by phone, email or otherwise. This includes information you provide when you register to use our site, download our App, subscribe to our service, participate in discussion boards or other social media functions on our site, enter a competition, promotion or survey, and when you report a problem with our site or our App. The information you give us may include your name, address, email address, phone number and personal description.

Information about other individuals. If you give us information on behalf of someone else, you confirm that the other person has appointed you to act on his/her behalf and has agreed that you can:

give consent on his/her behalf to the processing of his/her data;

receive on his/her behalf and data protection notices;

give consent to any transfer of his/her data;



We may retain a record of any contact you make with us.

Information we collect about you. With regard to each of your visits to our site and/or our App we may automatically collect the following information:

Technical information, including the Internet protocol (IP) address used to connect your computer or device to the internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform;

Information about your visit through use of cookies and similar tracking devices, including the full Uniform Resource Locators (URL) clickstream to, through and from our site (including date and time); products you viewed or searched for; page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page and any phone number used to call our customer service number.

Information about your device such as the type of mobile device that you are using and its unique device identifier (for example, the IMEI number, the device's mobile phone number, or the MAC address of the device's wireless network interface), the type of mobile browser that you are using, the mobile operating system that you are using, mobile network information and the time zone setting.

Information about your location using GPS technology or such other location tracking software we may use from time to time. Some of the features of our site and our App will require access to such location data to work. If you would like to use any such feature, you will be asked to consent to provide such location information. You can withdraw your consent to providing this information at any time by emailing us at iinfo@tuipoint.com

Information we receive from other sources. We may receive information about you if you use any of the other websites we operate or the other services we provide. In this case we will have informed you when we collected that data that it may be shared internally and combined with data collected on this site. We are also working closely with third parties (including, for example, business partners, sub-contractors in technical, payment and delivery services, advertising networks, analytics





providers, search information providers, credit reference agencies) and may receive information about you from them.

Cookies

Our website uses cookies to distinguish you from other users of our site and/or our App. This helps us to provide you with a good experience when you browse our site and/or our App and also allows us to improve our site.

A cookie is a small file of letters and numbers that we store on your browser or the hard drive of your computer or device if you agree. Cookies contain information that is transferred to your computer's or device's hard drive.

We use the following cookies:

These are cookies that are required for the operation of our site and/or our App. They include, for example, cookies that enable you to log into secure areas of our site and/or our App, use a shopping cart or make use of e-billing services.

Analytical/performance cookies. They allow us to recognise and count the number of visitors and to see how visitors move around our site and/or our App when they are using it. This helps us to improve the way our site and our App works, for example, by ensuring that users are finding what they are looking for easily.

Functionality cookies. These are used to recognise you when you return to our site and/or our App. This enables us to personalise our content for you, greet you by name and remember your preferences (for example, your choice of language or region).

Targeting cookies. These cookies record your visit to our site and/or our App, the pages you have visited and the links you have followed. We will use this information to make our site and our App and the advertising displayed on it more relevant to your interests. We may also share this information with third parties for this purpose.

Please note that third parties (including, for example, advertising networks and providers of external services like web traffic analysis services) may also use cookies, over which we have no control. These cookies are likely to be analytical/performance cookies or targeting cookies

You block cookies by activating the setting on your browser that allows you to refuse the setting of all or some cookies. However, if you use your browser settings to block

all cookies (including essential cookies) you may not be able to access all or parts of our site.

Except for essential cookies, all cookies will expire after the current browsing period has finished.

HOW WE USE YOUR INFORMATION

We use information held about you in the following ways:

Information you give to us. We will use this information:

to carry out our obligations arising from any contracts entered into between you and us and to provide you with the information, products and services that you request from us;

to provide you with information about other goods and services we offer that are similar to those that you have already purchased or enquired about;

to provide you, or permit selected third parties to provide you, with information about goods or services we feel may interest you. If you are an existing customer, we will only contact you by electronic means (email or SMS) with information about goods and services similar to those which were the subject of a previous sale or negotiations of a sale to you.

If you are a new customer, and where we permit selected third parties to use your data, we (or they) will contact you by electronic means only if you have consented to this. If you do not want us to use your data in this way, or to pass your details on to third parties for marketing purposes, please tick the relevant box situated on the form on which we collect your data;

to notify you about changes to our service;

to ensure that content from our site and our App is presented in the most effective manner for you and for your computer or device.

Information we collect about you. We will use this information:





to administer our site and our App for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes;

to improve our site and our App to ensure that content is presented in the most effective manner for you and for your computer or device;

to allow you to participate in interactive features of our service, when you choose to do so;

as part of our efforts to keep our site and our App safe and secure;

to measure or understand the effectiveness of advertising we serve to you and others, and to deliver relevant advertising to you;

to make suggestions and recommendations to you and other users of our site and our App about goods or services that may interest you or them.

Information we receive from other sources. We may combine this information with information you give to us and information we collect about you. We may us this information and the combined information for the purposes set out above (depending on the types of information we receive).

Disclosure of your information

We may share your personal information with any member of our group, which means our subsidiaries, our ultimate holding company and its subsidiaries.

We may share your information with selected third parties including:

Business partners, suppliers and sub-contractors for the performance of any contract we enter into with them or you.

Advertisers and advertising networks that require the data to select and serve relevant adverts to you and others. We do not disclose information about identifiable individuals to our advertisers, but we may provide them with aggregate information about our users (for example, we may inform them that 500 men aged under 30 have clicked on their advertisement on any given day). We may also use such aggregate information to help advertisers reach the kind of audience they want to target. We may make use of the personal data we have collected from you to enable





us to comply with our advertisers' wishes by displaying their advertisement to that target audience.

Analytics and search engine providers that assist us in the improvement and optimisation of our site and our App.

We may disclose your personal information to third parties:

In the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets.

If TUIPOINT or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets.

If we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or Apply our terms of use and other agreements; or to protect the rights, property, or safety of TUIPOINT, our customers, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.

Where we store your personal data

The data that we collect from you may be transferred to, and stored at, a destination within the European Economic Area ("EEA"). It may also be processed by staff operating within the EEA who work for us or for one of our suppliers. Such staff maybe engaged in, among other things, the fulfilment of your order and the provision of support services. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

All information you provide to us is stored on our secure servers. Where we have given you (or where you have chosen) a password which enables you to access certain parts of our site and/or our App, you are responsible for keeping this password confidential. We ask you not to share a password with anyone.





Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our site and or our App; any

transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.

WHAT YOU CAN DO TO KEEP YOUR INFORMATION SAFE

Protect your passwords

Choose a password that is difficult for others to guess. For example, don't use your pet's name, your birthday, or 1234. Preferably, use a mixure of letters, numbers and symbols.

It's safest to use different passwords for different accounts. If one password is compromised, the rest of your accounts will still be safe.

If you need to write down your passwords, keep them hidden somewhere (not in your wallet, or by your phone).

Protect your information online

Make sure you've got up-to-date anti-virus software, especially if you're shopping or banking online. Look for the padlock on a webpage, which suggests it's secure.

Emails from people you don't know often contain viruses that let others access your computer. Don't click on any links or attachments and delete the emails without responding.

Never email personal details like your bank account or credit card number to anyone, even if you think they're a friend. You don't always know who you're dealing with online.
